ORDER ADOPTING BUDGET FOR CALENDAR YEAR 2013

On this the 24 day of September, A. D. 2012, came on to be considered the Budget for estimated revenues and proposed County expenditures for the period beginning January 1, 2013, and ending December 31, 2013, and it appearing to the Court that said Budget is in accordance with law, and has been duly prepared by the County Judge on a modified accrual basis consistent with generally accepted accounting principles, and duly filed for inspection; that notice has been given in accordance with law for public hearing on the adoption of said Budget; and the said Budget having been duly considered by the Court with amendments thereto and corrections thereof having been made by the Court that the said Budget be, and it is hereby, approved and adopted showing the total appropriation of \$3,480,983.50. It is further ordered by the Court that the totals shown in said Budget for Personal Services, Benefits, Supplies, Other Services and Charges, and Capital Outlay be considered to be Budget Line Items, and that amounts shown for individual items included in such totals be considered to be supplementary information.

ORDER TO ADOPT TAX RATE FOR MASON COUNTY FOR THE YEAR 2012

Motion made by Commissioner Stephen Mutschink Seconded by Commissioner Wayne Hofmann

"I move that the property tax rate be increased by the adoption of a tax rate of §.5685 which is effectively a .000 percent increase in the tax rate and that §.4717 on the one hundred dollars assessed on the valuation be levied and collected for General Fund Purposes; that §.0052 on the one hundred dollars assessed valuation be levied and collected for the Airport Fund, that §.0616 on the one hundred dollars assessed valuation be levied and collected for Special Road and Bridge Fund Purposes and that §.03 on the one hundred dollars assessed valuation be levied and collected for the Debt Service Fund."

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY .000 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$36.33.
