ORDER ADOPTING BUDGET FOR CALENDAR YEAR 2021

On this the 31 day of August, A. ORDER TO ADOPT TAX RATE FOR MASON COUNTY FOR THE YEAR 2020

Motion made by Commissioner Loeffler.

Seconded by Commissioner Schuessler.

"I move that the property tax rate be increased by the adoption of a tax rate of \$0.590189 which is effectively a ZERO percent increase in the tax rate and that \$0.497116 on the one hundred dollars assessed on the valuation be levied and collected for General Fund Purposes, that \$0.005359 on the one hundred dollars assessed valuation be levied and collected for the Airport Fund, that \$0.087714 on the one hundred dollars assessed valuation be levied and collected for Special Road and Bridge Fund Purposes."

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY ZERO PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$16.88.

MASON COUNTY DISTRICT & COUNTY CLERK RECORDS MANAGEMENT PLAN

The District & County Clerk presents the following records management plans for each of the two funds specifically funded and established by Chapter 51 the Government Code.

SEC. 51.317 GOVERNMENT CODE RECORDS MANAGEMENT AND PRESERVATION FUND

District & County Clerk's Records Management and Preservation Fund Overview

This District & County Clerk's Records Management and Preservation Fund was established by act of the 78th Legislature through HB 1905, added Sec. 51.317(b)(4) and Sec. 51.317(c)(2) to the Government Code that established a new fee of \$10 upon filing of a new suit or other claims for relief, \$10.00 of which is designated for the District & County Clerk's Records Management and Preservation Fund. The effective date of the fee was January 1, 2004.

Sec. 51.317 (d) and (e) provides that the use of the fee be restricted to records management and preservation, including automation, subject to budget approval by the Commissioner Court. Any expenditure must comply with purchasing processes proscribed by Chapter 262 of the Local Government Code.

The purpose of this fee was to establish a source of funds through which District & County Clerks could enhance their respective records management operations beyond what is typically funded through a county's budget process.

The District & County Clerk's records management fees are charged upon the filing of a new court case or request for affirmative relief in an existing case; and recording of records in the Official Public Records in the County Clerk's Office.

Since the effective date of the fee, total revenue net of previous expenditures, FY18/19 budget allocations, and current encumbrances exceeds \$110,000.00 this amount is available for budgeting.

Status of Projects Funded in Previous Years

Document Management System for Official Public Records

Prior projects funded through Fund 055, the Indexing and scanning of Deed Records, Real Property Records, and Official Public Records. I am proud to say this has helped tremendously in researching and printing of the records. We no longer allow the books to be taken apart as we can print from our system back to 1858 when Mason County began recording these records.

SEC. 51.305 GOVERNMENT CODE DISTRICT COURT RECORDS TECHNOLOGY FUND

District & County Clerk's Records Technology Fund Overview

The District & County Clerk Records Archive Fee and District & County Clerk Records Technology Fund are authorized in Texas Government Code 51.305(b) and 51.305(c), respectively. Section 51.305(d) requires the authorized fee to be used for "the preservation and restoration services of the district & county court records archive." This section states, "the district & county clerk shall prepare an annual written plan for funding the preservation and restoration of the district clerk's records archive. The district clerk is to prepare an annual written plan for use of this fund. The Commissioners Court is required to hold a public hearing on this plan and to publish notice of such hearing in a newspaper no later than 15 days prior to the hearing.

Designation of Court Documents

The District & County Clerk recommends the following types and formats of documents be designated as "court documents" pursuant to Government Code 51.305:

- 1) all documents and records with a permanent retention period in accordance with the guidelines from the Texas State Library.
- 2) all documents which are maintained in electronic format.
- 3) all documents maintained in microfilm format.
- 4) all civil documents in paper format.
- 5) all criminal case documents in paper format in which the defendant was convicted of an offense or was placed on probation or supervision.

Strategy for Preservation of Court Documents

.The District & County Clerk's strategy is to:

a) Convert and maintain all court documents in electronic format. This allows documents to be viewed by multiple persons simultaneously, be searched according to a variety of criteria, stored in a cost-effective manner, redacted where appropriate to protect individual privacy, and easily and readily duplicated for purposes of disaster recovery.

Convert all court documents in paper format to electronic format.

This is a continuation of a project started in FY18/19 to provide a more secure and less costly method of maintaining and accessing these documents. A public use version of the electronic documents will be redacted to shield sensitive information from view.

- If and when required, acquire additional electronic storage, duplication, and retrieval capabilities.
 - Maintaining these images will require a large-scale electronic storage system. A system for maintaining a replicated copy of this database if needed to minimize risk. It will also help to ensure that Internet access to the records will not be occurring on the same system as the storage/main production database.
- Apply special preservation methods to documents of significant historic value. Modern preservation techniques should be applied to paper documents that merit special consideration.

FY20/21 PLAN FOR THE USE OF THE DISTRICT & COUNTY COURT RECORDS TECHNOLOGY FUND

The annual revenue from District Court Records Archive Fund will not be sufficient to fund all these activities, so the District Clerk is not requesting extensive expenditures from this fund at this time. This will allow the fund to accumulate revenue in order to fund more significant projects in the future. However, in order to enhance the scanning capacity within the department, an additional highspeed scanner and scanning supplies may be requested in the future:

LGC §118.011(f): The County Clerk of a county shall, if the commissioners court of the county adopts the fee as part of the county's annual budget, collect the following fee from any person: (1) Records Archive Fee (Sec. <u>11 8.025</u>) not more than \$10

LGC §118.025(c): The fee must be paid at the time a person, excluding a state agency, presents a public document to the county clerk for recording or filing.

NOTES

The Mason County Records Preservation Fee Reserve Balance is approximately \$ 110,000.00 .

The Archive Fee is separate from the \$10 Court Records Preservation Fee and it has over \$5,000.00 in it.

The Archive Fee is authorized under Chapter 118 LGC, Subchapter B. entitled "Fees of County Clerk Other than Court Fees"

Regarding the Records Archive Fee, the Texas Association of Counties Legal Department submitted the following in their 2017 Publication titled *Special and Dedicated Funds*:

Source [of revenue]: Fees paid for recording or filing services, set by the Commissioners' Court, not to exceed \$10. Optional, set by the Commissioners' Court. Accrued interest remains with this account. [Effective September 1, 2019, the filing/recording maximum allowable fee will be permanent. It was scheduled to be reduced to a maximum \$5 fee, but SB 658 will make the current \$10 maximum allowable amount a permanent figure.]

<u>Controlled by:</u> Clerk and Commissioners' Court, by agreement, subject to annual public hearing and commissioners court budgetary authorization.

<u>Purposes:</u> Monies may be expended only for the preservation and restoration services performed by the clerk in connection with maintaining a clerk's records archive on public documents designated by the clerk as part of the records thive.

<u>Additional Requirements:</u> Fee set by Commissioners' Court as part of budget process. Clerk designates public documents that are part of records archive and prepares plan to pay for preservation and restoration of records archive, subject to approval by the Commissioners' Court. Public hearing required.

BUDGET AND EXPENDITURES

Records preservation and restoration efforts are funded by revenue generated by the Clerk's Archival Fee. The plan may be adopted by the Commissioners' Court in compliance with LGC §118.025 and is itemized as part of the County's annual budget process. The maximum allowable fee amount is established by the Texas Local Government Code §118.011(f) and requires approval by the Commissioners' Court. Both currently and in the past the Commissioners' Court has approved that the Clerk collect \$ 10.00 for this fee which must be paid at the time any person, excluding a state agency, presents a public document to the County Clerk for recording or filing. The funds generated from the collection of this fee are expended only for the preservation and restoration services performed by the clerk in connection with maintaining a clerk's records archive on public documents. Funds not used in a fiscal year will carry over to the next fiscal year for expenditures as listed in the Annual Archival Plan.
